In the Matter of **Harold P. Mollin** and) **FINAL ORDER**
Customized Worldwide Weather Insurance Agency.) Case No. INS 01-07-005

The Director of the Oregon Department of Consumer and Business Services (Director) commenced the above entitled administrative proceeding pursuant to Oregon Revised Statutes (ORS) 731.256 to take disciplinary action against Harold P. Mollin (Mollin) and Customized Worldwide Weather Insurance Agency (CWWIA).

On July 17, 2001, the Director issued a Notice of Proposed Action (Notice) pursuant to ORS 183.415 proposing to revoke Mollin's and CWWIA's Oregon insurance agent licenses pursuant to ORS 744.013(1)(a) for allegedly violating a law specified therein. The Notice also informed Mollin and CWWIA that they had a right to a hearing and to be represented by an attorney at the hearing. The Notice also informed Mollin and CWWIA that if the Director issued a Final Order by default, then the Director designated a specified portion of the Insurance Division's file of this matter as part of the record for the purpose of proving a prima facie case upon default.

The Director did not receive from or on behalf of Mollin any request for a hearing.

The Director did not hold a hearing. However, the Director reviewed and considered the entire record in this matter, and found that the specified portion of the Insurance Division's file of this matter proved a prima facie case of the alleged violations.

Therefore, the Director makes the following final decision in this proceeding in accordance with ORS 731.248, 183.450 and 183.470 and related administrative rules.

Findings of Fact and Conclusions of Law

Licensing

According to the Insurance Division's records, Mollin has been licensed in Oregon as a nonresident individual agent since 6/28/91. Mollin's license number is 120297. Mollin's residence and business address is 1615 Northern Boulevard Suite 301, Manhasset NY 11030-3033 and telephone number is 516-365-7373.

According to our records, CWWIA has been licensed in Oregon as a non-resident firm or corporate agent since 6/28/91. CWWIA's license number is 23413. Mollin is an individual licensee employed by CWWIA. CWWIA's business address and telephone number are the same as Mollin's.

Disciplinary Action by Another State Insurance Regulatory Agency

Mollin and CWWIA are each subject to disciplinary action pursuant to ORS 744.013(2)(L) because the Connecticut Insurance Department issued an order, docket number MC 00-98, dated 12/6/00, revoking the non-resident insurance agent licenses issued to Mollin and CWWIA.

Order

The Oregon insurance agent licenses issued to Mollin and CWWIA shall be revoked on the date of this order pursuant to ORS 744.013(1)(a). Mollin and CWWIA shall not transact insurance in Oregon, including servicing clients, on and after that date.

Notice of Judicial Review

Pursuant to ORS 183.480 and 183.482, Mollin and CWWIA may request the Oregon Court of Appeals to review this order by filing a written petition for judicial review with the Court within 60 calendar days following the date this order is personally delivered or mailed to Mollin, whichever occurs first.
