**STIPULATION**

The Director of the Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against American Safety Casualty Insurance Company (American Safety).

American Safety enters into this Stipulation, pursuant to ORS 183.415(5), to conclude this proceeding without further administrative or judicial proceedings.

American Safety waives the right to receive a notice of proposed action, to receive a notice of the rights of a party and procedures in contested cases, to have a hearing, to be represented by an attorney at the hearing, to receive a proposed order, to file exceptions to the proposed order, and to judicial review of the Final Order.

American Safety admits and agrees to the following facts, conclusions, and action.

**Facts and Conclusions**

Licensing Information

American Safety has been licensed in Oregon as an insurer since 9/15/82. American Safety's Oregon Insurance Division company number is 2454 and its NAIC identification number is 39969. American Safety's principal business mailing address is in Atlanta, Georgia.

Filed Special Oregon Schedule P Late

American Safety violated ORS 731.574(1) engaging in the following conduct. American Safety was required to mail its Special Oregon Schedule P for 2002 to the director by 3/3/03. American Safety mailed the Schedule P on 3/26/03, 23 days late.

**Action**

Pursuant to ORS 731.988, American Safety shall pay a civil penalty of \$2,300. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at 350 Winter Street NE, Room 440, Salem, OR 97301-3883, or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be received by the Insurance Division by the date of the Final Order.
