STIPULATION

The Director of the Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Hyundai Marine & Fire Insurance Company (Hyundai Marine).

Hyundai Marine enters into this Stipulation, pursuant to ORS 183.415(5), to conclude this proceeding without further administrative or judicial proceedings.

Hyundai Marine waives the right to receive a notice of proposed action, to receive a notice of the rights of a party and procedures in contested cases, to have a hearing, to be represented by an attorney at the hearing, to receive a proposed order, to file exceptions to the proposed order, and to judicial review of the Final Order.

Hyundai Marine admits and agrees to the following facts, conclusions, and action.

Facts and Conclusions

Licensing Information

Hyundai Marine has been licensed in Oregon as an insurer since 11/26/1996. Hyundai Marine's Oregon Insurance Division company number is 3030 and its NAIC identification number is 10048. Hyundai Marine's principal business mailing address is in New York, New York.

Filed Special Oregon Schedule P Late

Hyundai Marine violated ORS 731.574(1) engaging in the following conduct. Hyundai Marine was required to mail its Special Oregon Schedule P for 2002 to the director by 3/3/03. Hyundai Marine mailed the Schedule P on 3/21/03, 18 days late.

Action

Pursuant to ORS 731.988, Hyundai Marine shall pay a civil penalty of \$1,800. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at 350 Winter Street NE, Room 440, Salem, OR 97301-3883, or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be received by the Insurance Division by the date of the Final Order.
