STIPULATION

The Director of the Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against OneBeacon America Insurance Company (OneBeacon America).

OneBeacon America enters into this Stipulation, pursuant to ORS 183.415(5), to conclude this proceeding without further administrative or judicial proceedings.

OneBeacon America waives the right to receive a notice of proposed action, to receive a notice of the rights of a party and procedures in contested cases, to have a hearing, to be represented by an attorney at the hearing, to receive a proposed order, to file exceptions to the proposed order, and to judicial review of the Final Order.

OneBeacon America admits and agrees to the following facts, conclusions, and action.

Facts and Conclusions

Licensing Information

OneBeacon America has been licensed in Oregon as an insurer since 04/01/1971. OneBeacon America's Oregon Insurance Division company number is 1851 and its NAIC identification number is 20621. OneBeacon America's principal business mailing address is in Boston, Massachusetts.

Filed Special Oregon Schedule P Late

OneBeacon America violated ORS 731.574(1) engaging in the following conduct. OneBeacon America was required to mail its Special Oregon Schedule P for 2002 to

the director by 3/3/03. OneBeacon America mailed the Schedule P on 3/6/03, 3 days late.

Action

Pursuant to ORS 731.988, OneBeacon America shall pay a civil penalty of \$300. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at 350 Winter Street NE, Room 440, Salem, OR 97301-3883, or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be received by the Insurance Division by the date of the Final Order.
