STIPULATION

The Director of the Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against John S. Belinkie (Belinkie).

Belinkie enters into this Stipulation, pursuant to ORS 183.415(5), to conclude this proceeding without further administrative or judicial proceedings.

Belinkie waives the right to receive a notice of proposed action, receive a notice of the rights of a party and procedures in contested cases, have a hearing, be represented by an attorney at the hearing, receive a proposed order, file exceptions to the proposed order, and have the Final Order judicially reviewed.

Belinkie stipulates to the following facts, conclusions, and action; and consents to issuance of a Final Order incorporating this Stipulation.

Facts and Conclusions

Licensing Information

Belinkie has been licensed in Oregon as a nonresident insurance agent since 4/24/01. Belinkie's current license number is 167555. Belinkie's last recorded residence address is located in Rockville, Maryland.

Failed to Report Enforcement Action by Other State Insurance Regulator

Belinkie violated ORS 744.089(1) in two instances by engaging in the following conduct. ORS 744.089(1) requires a person licensed in Oregon as an insurance agent to notify the Insurance Division of any administrative action taken against the person, and provide a copy of the order, within 30 days of the final disposition of the action.

1. On 8/2/02, the insurance regulator for the State of Virginia issued an order, number INS-2002-00174, assessing Belinkie a civil penalty of \$1,000. The insurance regulator took the action because Belinkie failed "to pay funds in the ordinary course of business to the insured ... entitled to the payment." Belinkie was required to notify

the Insurance Division of the action, and provide a copy of the order, by 9/2/02. On 10/24/02, the Insurance Division received from Belinkie a letter dated 10/24/02 notifying the Insurance Division of the action and providing a copy of the order.

2. On 12/17/02, the insurance regulator for the State of Indiana issued an order, number IDOI-AG02-098, assessing Belinkie a civil penalty of \$500. The insurance regulator took the action because failed to report to Indiana Virginia's administrative action against Belinkie. Belinkie was required to notify the Insurance Division of the action, and provide a copy of the order, by 1/16/03. On 8/12/03, the Insurance Division received by fax from Belinkie a letter dated 8/11/03 notifying the Insurance Division of the action and providing a copy of the order.

Action

Pursuant to ORS 731.988, Belinkie is assessed a civil penalty of \$400. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at 350 Winter Street NE, Room 440, Salem, OR 97301-3883, or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be received by the Insurance Division by the date of the Final Order.
