History of the Proceeding

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Kevin B. Dermody (Dermody).

On 8/27/04, the director notified the party that they were entitled to a hearing pursuant to ORS 183.415.

The director did not receive a request for a hearing, and did not hold a hearing because the director determined that the record of the proceeding proved a *prima facie* case and no further evidence was needed.

Therefore, the director now makes the following final decision in this proceeding.

Findings of Fact and Conclusions of Law

Licensing Information

Dermody has been licensed in Oregon as nonresident insurance agent since 12/14/00

Agent Not Licensed in Resident State

Dermody is subject to enforcement action pursuant to ORS 744.063(1)(a) because of the following circumstances. ORS 744.063(1)(a) requires a person licensed in Oregon as a nonresident insurance agent to be also licensed in the person's state of residence as a resident insurance producer. At all relevant times, Dermody was a resident of Illinois. On 11/6/03, the insurance regulator of the State of Illinois issued an order revoking Dermody's Illinois resident insurance agent license effective 12/6/03 if Dermody did not request a hearing by the effective date.

Dermody did not request a hearing. Thus, the action was effective on 12/6/03. The insurance regulator took the action because the securities regulator for the State of

Illinois issued an order, dated 12/2/02, revoking Dermody's registration as an investment salesperson and investment advisor in Illinois. Therefore, Dermody has not qualified for an Oregon nonresident insurance agent license since 12/21/03.

Order

Pursuant to ORS 744.074(1), Dermody's Oregon nonresident insurance agent license is revoked on the date of this order.

Notice of Right to Judicial Review

The party may have the right to appeal the order to the Oregon Court of Appeals pursuant to ORS 183.480 and 183.482. If a party wants to appeal the order, the party must file a petition for judicial review with the Court of Appeals within 60 days from the date this order was served on the party. If the order was personally delivered to a party, then the date of service is the day the party received the order. If the order was mailed to a party, then the date of service is the day the order was mailed to the party, not the day the party received the order. If a party does not file a petition for judicial review within the 60-day time period, then the party will lose the right to appeal this order. If a party appeals the order, the party should also send a copy of the petition to the Insurance Division.
