Whereas the Director of the Oregon Department of Consumer and Business Services (director); and AIU Insurance Company, American Home Assurance Company, AIG Casualty Company, Commerce and Industry Insurance Company, Granite State Insurance Company, Illinois National Insurance Company, National Union Fire Insurance Company of Pittsburgh PA, New Hampshire Insurance Company, and The Insurance Company of the State of Pennsylvania (collectively referred to as AIG), entered into a Stipulation and Final Order dated July 5, 2007 (order);

Whereas the order assessed AIG a fine for certain violations of the Oregon Insurance and Workers' Compensation laws but suspended part of the civil penalty if, among other things, AIG achieved progressively increasing performance levels within successive time periods;

Whereas AIG has cooperated with the director to achieve compliance in accordance with the terms and provisions of the order;

Whereas AIG has achieved improved performance levels;

Whereas AIG nevertheless failed to achieve all required performance levels;

Whereas AIG and the director have agreed to extend the final period during which AIG must achieve and maintain certain performance levels, and to extend

the date by which the director shall determine whether to assess any or all of the suspended civil penalty,

Therefore, the director and AIG amend the order as follows:

1. On page 6 of the order, the date “September 30, 2008” is changed to “September 30, 2010.”
2. Exhibit A of the order is replaced with the attached Amended Exhibit A.

This amendment shall become effective on the date the director signs this amendment.
