STIPULATION

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Connecticut General Life Insurance Company (Connecticut General).

Connecticut General desires to conclude this proceeding without a hearing by entering into this stipulation pursuant to ORS 183.415(5).

Connecticut General waives all rights relative to an administrative hearing and judicial review thereof.

Connecticut General stipulates to the following facts, conclusions, action, and to the issuance of a final order incorporating this stipulation.

Facts and Conclusions

Licensing Information

Connecticut General has been licensed in Oregon as a foreign insurer since 2/5/46. Connecticut General's last recorded principal business address is located in Philadelphia, Pennsylvania.

Filed Prompt Pay Health Claim Report Containing Extraneous Information

Connecticut General is subject to enforcement action pursuant to Oregon Administrative Rules (OAR) 836-080-0085(2)(a) because of the following circumstances. ORS 743.911(1) requires an insurer to pay a clean claim under a health benefit plan within 30 days after receiving the claim or after receiving any required additional information whichever is later. OAR 836-080-0085(2) requires an insurer to file with the director by March 1 of each year a report, referred to as a prompt pay report, of all clean claims, as defined in OAR 836-080-0080(1), of health

benefit plans, as defined in ORS 743.730(19), that the insurer received from a provider on behalf of an enrollee, as defined in ORS 743.730(14), containing certain information. OAR 8236-080-0085(2)(a) requires the report to contain all clean claims that were finally disposed of during the immediately preceding year. On 3/4/08/08, the director received from Connecticut General its prompt pay report for 2007. The report contained information about 22 claims that were finally disposed of in 2008.

Action

Pursuant to ORS 731.988, Connecticut General is assessed a civil penalty of \$2,000.00. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at the Labor and Industries Building, 350 Winter Street NE, Room 440 (4th Floor), Salem, Oregon; or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be *received* by the Insurance Division by the date of the final order.
