STIPULATION

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Dennis W. Marbell (Marbell).

Marbell desires to conclude this proceeding without a hearing by entering into this stipulation pursuant to ORS 183.417(3).

Marbell waives all rights relative to an administrative hearing and judicial review thereof.

Marbell stipulates to the following facts, conclusions, action, and to the issuance of a final order incorporating this stipulation.

Facts and Conclusions

Licensing Information

Marbell has been licensed in Oregon as a nonresident insurance producer from 4/23/02 to 1/15/04 and as a resident insurance producer since 1/16/04. Marbell's last recorded residence and business address is located in Bend, Oregon.

Forged Person's Name on Application for Insurance or Related Document

Marbell is subject to enforcement pursuant to ORS 744.074(1)(k) because of the following circumstances. ORS 744.074(1)(k) permits the director to take any authorized enforcement action against a person who has applied for a license or is licensed in Oregon as an insurance producer if the person forged another person's name to an application for insurance or to any document related to an insurance transaction. On 6/27/07, in three instances, Marbell completed an application to a reinstate a life insurance policy issued by Farmers New World Life Insurance

Company, answered certain questions about the health of the insured, paid the reinstatement premium, and signed the name of the insured, without the knowledge or consent of the insured.

Action

Pursuant to ORS 731.988(1), Marbell is assessed a civil penalty of \$3,000.00. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at the Labor and Industries Building, 350 Winter Street NE, Salem, Oregon; or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be *received* by the Insurance Division by 2/1/10.
