The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Kimberly J. Lakey (Lakey).

The director makes the following final decision in this proceeding.

Findings of Fact and Conclusions of Law

Licensing Information

Lakey has been licensed in Oregon as a resident individual insurance producer since 11/18/09. Lakey's license is scheduled to expire on 8/31/12. Lakey's license number is 220157, and NAIC national producer number is 15039654. Lakey's last recorded residence address is 2572 Wisteria Court, West Linn, OR 97068-7315; and telephone number is 503-793-2071. Lakey's last recorded principal place of business address is Town & Country Chrysler, Inc. dba Town & Country Mitsubishi, 16800 SE McLoughlin Boulevard, Milwaukie, OR 97267-4956; and telephone number is 503-659-0570.

License Subject to Suspension Pursuant to ORS 25.750 to 25.783

Lakey is subject to enforcement action pursuant to ORS 25.780(1) because of the following circumstances. ORS 25.780(1) requires an "entity that issues licenses, certificates, permits or registrations that a person is required by state law to possess to engaged in an occupation, [or] profession ...to suspend without further hearing the license, certificate, permit or registration of a person upon certification by the administrator [as defined in ORS 25.010(1)] that the person is subject to an order suspending the license, certificate, permit or registration. The certification must include the information specified in ORS 25.750(1)." On 12/7/11, the director

received from the Benton County District Attorney a notice to suspend dated 12/5/11 certifying that Lakey is subject to an order suspending Lakey's Oregon insurance producer license pursuant to ORS 25.780(1). The certification included the information specified in ORS 25.750(1).

Order

Pursuant to ORS 744.074(1) and ORS 25.780(1), Lakey's Oregon resident individual insurance producer license is suspended and shall not be renewed; and any other license authorized by ORS Chapter 744 shall not be issued to Lakey, from the date of this order until (1) the director receives from the Benton County District Attorney a written notice pursuant to ORS 25.774 that the director may reinstate or renew the suspended license or issue a new license, (2) Lakey otherwise qualifies for a license, and (3) the director issues an order terminating the suspension.

Notice of Right to Judicial Review

A party has the right to judicial review of this order pursuant to ORS 183.480 and ORS 183.482. A party may request judicial review by sending a petition for judicial review to the Oregon Court of Appeals. The court must receive the petition within 60 days from the date this order was served on the party. If the order was personally delivered to a party, then the date of service is the date the party received the order. If the order was mailed to a party, then the date of service is the date the order was mailed to the party, not the date the party received the order.
