**History of the Proceeding**

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Lisa L. Brumand-Far (Brumand-Far).

On 12/2/11, the director issued a notice of proposed action informing the party that the director proposed to take enforcement action against the party, the party was entitled to a hearing pursuant to ORS 183.415, and if the party wanted a hearing then the party had to send to the director a written request for a hearing so that the director received it by 12/23/11. The notice also informed the party that if a hearing was not conducted then the designated portion of the Insurance Division's file and all materials submitted by the party in this case would automatically become part of the contested case record for the purpose of proving a *prima facie* case.

The director did not receive from the party a request for a hearing and did not conduct a hearing.

The director finds that the record of this proceeding proves a *prima facie* case.

The director now makes the following final decision in this proceeding.

**Findings of Fact and Conclusions of Law**

Brumand-Far, aka Lisa L. Baker and Lisa L. Jacobson, has been licensed in Oregon as a resident individual insurance producer since 3/3/10. On 9/29/11, Brumand-Far's license was suspended from 9/29/11 to 12/2/11 pursuant to ORS 744.074(1) and ORS 25.780(1). Brumand-Far's license is scheduled to expire on 8/31/12. Brumand-Far's license number is 220830, and NAIC national producer number is 10996670. Brumand-Far's last recorded residence address is 2656 River

Road South Apartment C, Salem, OR 97302-5849; and telephone number is 503-995-4449. Brumand-Far's last recorded principal place of business address is AFLAC, 1100 Liberty Street SE Suite 4, Salem, OR 97302-4154; and telephone number is 503-365-3632. However, on an unknown date, Brumand-Far moved from Oregon to Nevada and as of at least 12/22/11 her current residence address is 2600 Orchard Meadows Avenue, Henderson, NV 89074-1971.<sup>1</sup>

Failed to Respond to Director's Inquiry

Brumand-Far is subject to enforcement action pursuant to ORS 731.296 because of the following circumstances.

ORS 744.074(1)(b) permits the director to take any authorized enforcement action against a person who has applied for a license or is licensed in Oregon as an insurance producer if the person violated any insurance statute; or any rule, order, or subpoena, of the director or the insurance regulator of another state.

ORS 731.296 requires a person who is licensed in Oregon in any capacity under the Insurance Code to promptly and truthfully respond to an inquiry from the director.

On 11/3/11, the director mailed by certified mail a letter dated 11/3/11 to Brumand-Far at both her last recorded residence address of 2656 River Road South Apartment C, Salem, OR 97302-5849, and to her last known residence address of 2600 Orchard Meadows Avenue, Henderson, NV 89074-1971. The letter requested Brumand-Far to provide certain information to the director by 11/23/11. The letter mailed to Brumand-Far at her last recorded residence address in Salem, Oregon was returned to the director on 11/7/11 because Brumand-Far did not claim it. The letter mailed to Brumand-Far at her last recorded residence address in Henderson, Nevada was returned to the director on 1/10/12 because Brumand-Far did not claim it. Brumand-Far did not provide to the director the requested information.

## Order

Pursuant to ORS 744.074(1), Brumand-Far's Oregon resident individual insurance producer license is revoked on the date of this order.

### Notice of Right to Judicial Review

A party has the right to judicial review of this order pursuant to ORS 183.480 and ORS 183.482. A party may request judicial review by sending a petition for judicial review to the Oregon Court of Appeals. The court must receive the petition within 60 days from the date this order was served on the party. If the order was personally delivered to a party, then the date of service is the date the party received the order. If the order was mailed to a party, then the date of service is the date the order was mailed to the party, not the date the party received the order. If a party files a petition, the party is requested to also send a copy of the petition to the Insurance Division by delivering it to the Labor and Industries Building, 350 Winter Street NE Room 300, Salem, OR 97301-3880; or mailing it to PO Box 14480, Salem, OR 97309-0405; or faxing it to 503-378-4351; or e-mailing it to [mitchel.d.curzon@state.or.us](mailto:mitchel.d.curzon@state.or.us).
