The Director of the Oregon Department of Consumer and Business Services (director), by and through the Insurance Division, commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Mark A. Page (Page).

The director makes the following final decision in this proceeding.

**Findings of Fact and Conclusions of Law**

Licensing Information

Page has been most recently licensed in Oregon as a resident individual insurance producer since 11/1/12. Page's license is scheduled to expire on 5/31/15. Page's NAIC national producer number is 6406941. Page's last recorded residence mailing address is PO Box 821, Portland, OR 97207-0821; and telephone number is 501-438-6997. Page's last recorded business street address is 750 SW Oak Street, Hillsboro, OR 97123-3808; telephone number is 503-735-7300; and e-mail address is [mark.page@lhm.com](mailto:mark.page@lhm.com).

License Subject to Suspension Pursuant to ORS 25.750 to 25.783

Page is subject to enforcement action pursuant to ORS 25.780(1). ORS 25.780(1) requires an "entity that issues licenses, certificates, permits or registrations that a person is required by state law to possess to engaged in an occupation, [or] profession ...to suspend without further hearing the license, certificate, permit or registration of a person upon certification by the administrator [as defined in ORS 25.010(1)] that the person is subject to an order suspending the license, certificate, permit or registration. The certification must include the information specified in ORS 25.750(1)." On 5/13/15, the director received from the Multnomah County District Attorney (District Attorney) a notice to suspend dated 5/9/15

informing the director that the director was required to suspend Page's license pursuant to ORS 25.780(1). The notice included the information specified in ORS 25.750(1).

**Order**

Pursuant to ORS 25.780(1), Page's Oregon resident individual insurance producer license is suspended and shall not be renewed, and any other license authorized by ORS Chapter 744 shall not be issued to Page, from the date of this order until the director receives from the District Attorney a written notice pursuant to ORS 25.774 that the director may reinstate or renew the suspended license or issue a new license, and the director issues an order terminating the suspension.

**Notice of Right to Judicial Review**

A party has the right to judicial review of this order pursuant to ORS 183.480 and ORS 183.482. A party may request judicial review by sending a petition for judicial review to the Oregon Court of Appeals. The court must receive the petition within 60 days from the date this order was served on the party. If the order was personally delivered to a party, then the date of service is the date the party received the order. If the order was mailed to a party, then the date of service is the date the order was mailed to the party, not the date the party received the order. If a party files a petition, the party is requested to also send a copy of the petition to the Insurance Division by delivering or mailing it to the Insurance Division at Labor and Industries Building, 350 Winter Street NE Room 300, Salem, Oregon 97301-3880; or mailing it to PO Box 14480, Salem, OR 97309-0405; or faxing it to 503-378-4351; or e-mailing it to [mitchel.d.curzon@oregon.gov](mailto:mitchel.d.curzon@oregon.gov).


