FINAL ORDER TO CEASE AND  
DESIST AND ORDER DENYING  
APPLICATION, ENTERED BY  
DEFAULT

On February 10, 2016, the Director of the Department of Consumer and Business Services (“Director”), by and through the Division of Financial Regulation (“Division”), properly served Notice on Gregory Omer (“Respondent”) that the Director intended to refuse to issue Respondent’s Resident Insurance Producer License.

The Notice offered Respondent an opportunity for a hearing, if requested within 60 days. The Notice further informed Respondent that if a hearing was not conducted because Respondent did not timely request a hearing or otherwise defaulted, then the designated portion of the Director’s file and all materials submitted by Respondent in this case would automatically become part of the contested case record for the purpose of proving a *prima facie* case.

The Director did not receive from Respondent a request for a hearing and did not conduct a hearing.

The Director finds that the record of this proceeding proves a *prima facie* case.

The Director makes the following Findings of Fact, Conclusions of Law, Orders, and Notice of Right to Judicial Appeal.

FINDINGS OF FACT

The Director FINDS that:

1. Respondent applied for a License on or about December 11, 2015.

2 NOW, THEREFORE, THE DIRECTOR ISSUES THE FOLLOWING ORDERS:

3 10. As authorized by ORS 731.252(1), the Director ORDERS Respondent to  
4 CEASE AND DESIST from violating any provision of the Insurance Code or the  
5 administrative rules promulgated thereunder.

6 11. The Director, pursuant to ORS 744.074(1)(a), hereby DENIES Respondent's  
7 application for an Oregon Resident Insurance Producer's License.
