11 DEFAULT

12 On March 21, 2016, the Director of the Department of Consumer and Business
13 Services (“Director”), by and through the Division of Financial Regulation (“Division”),
14 properly served Notice on Dana Hutchison (“Applicant”) that the Director intended to
15 refuse to issue Applicant’s Non-resident Insurance Producer License.

16 The Notice offered Applicant an opportunity for a hearing, if requested within 60
17 days. The Notice further informed Applicant that if a hearing was not conducted because
18 Applicant did not timely request a hearing or otherwise defaulted, then the designated
19 portion of the Director’s file and all materials submitted by Applicant in this case would
20 automatically become part of the contested case record for the purpose of proving a
21 *prima facie* case.

22 The Director did not receive from Applicant a request for a hearing and did not
23 conduct a hearing.

24 The Director finds that the record of this proceeding proves a *prima facie* case.

25 The Director makes the following Findings of Fact, Conclusions of Law, Orders,
26 and Notice of Right to Judicial Appeal.
