8 Respondent.

9 On April 14, 2016, the Director of the Department of Consumer and Business
10 Services (“Director”), by and through the Division of Financial Regulation (“Division”),
11 properly served Notice on Bradley Zimmer (“Respondent”) that the Director intended to
12 revoke Respondent’s Resident Insurance Producer License.

13 The Notice offered Respondent an opportunity for a hearing, if requested within
14 30 days. The Notice further informed Respondent that if a hearing was not conducted
15 because Respondent did not timely request a hearing or otherwise defaulted, then the
16 designated portion of the Director’s file and all materials submitted by Respondent in this
17 case would automatically become part of the contested case record for the purpose of
18 proving a *prima facie* case.

19 The Director did not receive from Respondent a request for a hearing and did not
20 conduct a hearing.

21 The Director finds that the record of this proceeding proves a *prima facie* case.

22 The Director makes the following Findings of Fact, Conclusions of Law, Orders,
23 and Notice of Right to Judicial Appeal.

24 FINDINGS OF FACT

25 The Director FINDS that:

1 opening or closing of a location at which the producer transacts business within 30 days
2 after the date of change. Respondent did not inform the Division that he had closed his
3 business location within 30 days.

4 9. ORS 744.068(4)(c) requiring an insurance producer to notify the Division of a
5 change of residence within 30 days after the date of change. Respondent failed to inform
6 the Division of change of residence within 30 days.

7 10. Under ORS 744.074(1)(b), the Director may place a licensee on probation or
8 suspend, revoke or refuse to issue or renew an insurance producer license and may take
9 other actions authorized by the Insurance Code for anyone violating any insurance laws,
10 or violating any rule.

11
12 **ORDERS**

13 Now therefore, the Director issues the following Orders:

14 11. As authorized by ORS 731.252(1), the Director ORDERS Respondent to
15 CEASE AND DESIST from violating any provision of the Oregon Insurance Code or the
16 administrative rules promulgated thereunder.

17 12. The Director, pursuant to ORS 744.074, hereby REVOKES Respondent's
18 Oregon Resident Insurance Producer License.
