8 Applicant.

9 On March 21, 2016, the Director of the Department of Consumer and Business
10 Services (“Director”), by and through the Division of Financial Regulation (“Division”),
11 properly served Notice on Mark Buczko (“Applicant”) that the Director intended to
12 revoke Applicant’s Non-resident Insurance Producer License.

13 The Notice offered Applicant an opportunity for a hearing, if requested within 60
14 days. The Notice further informed Applicant that if a hearing was not conducted because
15 Applicant did not timely request a hearing or otherwise defaulted, then the designated
16 portion of the Director’s file and all materials submitted by Applicant in this case would
17 automatically become part of the contested case record for the purpose of proving a
18 *prima facie* case.

19 The Director did not receive from Applicant a request for a hearing and did not
20 conduct a hearing.

21 The Director finds that the record of this proceeding proves a *prima facie* case.

22 The Director makes the following Findings of Fact, Conclusions of Law, Orders,
23 and Notice of Right to Judicial Appeal.

25 FINDINGS OF FACT

26 The Director FINDS that:

Now therefore, the Director issues the following Orders:

9. As authorized by ORS 731.252(1), the Director ORDERS Applicant to
8 CEASE AND DESIST from violating any provision of the Insurance Code or the
9 administrative rules promulgated thereunder.

10. The Director, pursuant to ORS 744.074(1)(a), hereby REVOKES the
11 Applicant's Oregon Non-resident Insurance Producer's License.
