9 FINAL ORDER TO CEASE AND
10 DESIST AND ORDER DENYING
11 APPLICATION, ENTERED BY
12 DEFAULT

13 On March 24, 2016, the Director of the Department of Consumer and Business
14 Services (“Director”), by and through the Division of Financial Regulation (“Division”),
15 properly served Notice on Timothy P. Winders (“Applicant”) that the Director intended
16 to refuse to issue Applicant’s Non-resident Insurance Producer License.

17 The Notice offered Applicant an opportunity for a hearing, if requested within 60
18 days. The Notice further informed Applicant that if a hearing was not conducted because
19 Applicant did not timely request a hearing or otherwise defaulted, then the designated
20 portion of the Director’s file and all materials submitted by Applicant in this case would
21 automatically become part of the contested case record for the purpose of proving a
22 *prima facie* case.

23 The Director did not receive from Applicant a request for a hearing and did not
24 conduct a hearing.

25 The Director finds that the record of this proceeding proves a *prima facie* case.

26 The Director makes the following Findings of Fact, Conclusions of Law, Orders,
and Notice of Right to Judicial Appeal.

2 Now therefore, the Director issues the following Orders:

3 9. As authorized by ORS 731.252(1), the Director ORDERS Applicant to
4 CEASE AND DESIST from violating any provision of the Insurance Code or the
5 administrative rules promulgated thereunder.

6 10. The Director, pursuant to ORS 744.074(1)(a), hereby DENIES Applicant's
7 application for a Non-Resident Insurance Producer License.
