FINAL ORDER

6 Licensee.

7  
8 On May 10, 2016, the Director of the Department of Consumer and Business  
9 Services (“Director”), by and through the Division of Financial Regulation (“Division”),  
10 properly served notice (“Notice”) on Richard H. Jackson (“Licensee”) that the Director  
11 intended to issue an order revoking Licensee’s resident insurance producer license.

12 The Notice offered Licensee an opportunity for a hearing if requested within 20  
13 days of service of the Notice. The Notice further informed Licensee that if a hearing was  
14 not conducted because Licensee did not timely request a hearing or otherwise defaulted,  
15 then the designated portion of the Division’s file and all materials submitted by Licensee  
16 in this case would automatically become part of the contested case record for the purpose  
17 of proving a prima facie case.

18 The Director did not receive from Licensee a request for a hearing and did not  
19 conduct a hearing.

20 The Director finds that the record of this proceeding proves a prima facie case.

21 Now, therefore, after considering the relevant portions of the Division’s file  
22 relating to this matter, the Director finds and orders as follows.

23 FINDINGS OF FACT

24 The Director FINDS that:

25 1. Licensee has been licensed as an Oregon resident insurance producer since  
26 around August 28, 1992. Licensee’s national producer number is 1500931.

1 AND DESIST from violating any provision of the Insurance Code or the administrative  
2 rules promulgated thereunder.

3 12. Based upon the foregoing and in accordance with ORS 744.074(1)(b), the  
4 Director REVOKES Licensee's resident insurance producer license for violating ORS  
5 744.089(2).

6 13. Based upon the foregoing and in accordance with ORS 744.074(1)(f), the  
7 Director REVOKES Licensee's resident insurance producer license for being convicted  
8 of ten felonies.
