DESIST AND ORDER REVOKING
LICENSE, ENTERED BY DEFAULT

Respondent.

On June 24, 2016, the Director of the Department of Consumer and Business Services for the State of Oregon (hereafter the “Director”), by and through the Division of Financial Regulation (“Division”), acting pursuant to the authority set forth in ORS 744.074, properly served notice (“Notice”) on Jared N. Helfant (“Respondent”) that the Director intended to issue and order revoking Respondent’s non-resident insurance producer license.

The Notice offered Respondent an opportunity for a hearing, if requested within 20 days of service of the Notice. The Notice further informed Respondent that if a hearing was not conducted because Respondent did not timely request a hearing or otherwise defaulted, then the designated portion of the Division’s file and all materials submitted by Respondent in this case would automatically become part of the contested case record for the purpose of proving a prima facie case.

The Director did not receive a hearing request from Respondent and did not conduct a hearing.

The Director finds that the record of this proceeding proves a prima facie case.

Now, therefore, after considering the relevant portions of the Director’s file relating to this matter, Director finds and orders as follows.

FINDINGS OF FACT

The Director FINDS that:

3 8. Under ORS 744.074(1)(i), the Director may revoke an insurance producer
4 license for the cancellation, revocation, suspension or refusal to renew by any state. The
5 record of the cancellation, revocation, suspension or refusal to renew shall be conclusive
6 evidence of the action taken.

8 **ORDERS**

9 Now, therefore, the Director issues the following Orders:

10 9. As authorized by ORS 731.252(1), the Director ORDERS Respondent to
11 CEASE AND DESIST from violating any provision of the Insurance Code or the
12 administrative rules promulgated thereunder.

13 10. Based upon the foregoing and in accordance with ORS 744.074(1)(b) and
14 ORS 744.074(1)(i), hereby REVOKES Respondent's non-resident insurance producer
15 license.
