CONSENT TO ENTRY OF ORDER

9 WHEREAS the Director of the Department of Consumer and Business
10 Services has conducted an investigation of certain business activities conducted by
11 Gary Buchanan and Turfmate Products, Inc., and has determined that Gary
12 Buchanan and Turfmate Products, Inc., sold unregistered securities and conducted
13 the unlicensed sale of securities in Oregon in violation of the Oregon Securities Law.

14 WHEREAS Gary Buchanan and Turfmate Products, Inc., wish to resolve and
15 settle this matter by entry into this Consent Order;

16 NOW THEREFORE, as evidenced by the authorized signature(s) subscribed
17 on this Order, Gary Buchanan and Turfmate Products, Inc., hereby CONSENT to
18 entry of this Order to Cease and Desist upon the Director's Findings of Fact and
19 Conclusions of Law as stated hereinafter.

20 FINDINGS OF FACT

21 The Director FINDS that:

22 1. Turfmate Products, Inc., ("Turfmate") is a Nevada corporation, whose principal
23 place of business is 415 River Street, Cave Junction, Oregon 97523. Gary
24 Buchanan ("Buchanan") is the sole Director of Turfmate and a resident of the State of
25 Oregon.

1 The Director, pursuant to ORS 59.995, **HEREBY ORDERS** the following **CIVIL**
2 **PENALTIES:**

3 1. Respondents Gary Buchanan and Turfmate Products, Inc., shall be
4 denied the use of any securities licensing or registration exemptions contained in the
5 Oregon Securities Laws, including ORS Chapter 59 and OAR Chapter 441.

6 2. Respondents Gary Buchanan and Turfmate Products, Inc., shall pay a
7 civil penalty in the amount of \$10,000, due upon execution of this Order. The
8 imposition of this civil penalty shall be suspended, so long as neither Respondent
9 violates this Order or any provision of Oregon Securities Law, including ORS
10 Chapter 59 and OAR Chapter 441.

11 The entry of this Order in no way limits further remedies which may be
12 available to the Director under Oregon Law.
