**FINDINGS OF FACT**

- 2) WSC did not request a hearing before entry of the Final Order  
 in this matter.

2 salesperson in Oregon on or about January 13, 2003.  
3 4) As of the date of entry of the Final Order in this matter,  
4 June 12, 2003, WSC had not licensed a salesperson in Oregon.  
5 5) On July 23, 2003, Respondent submitted a Request to Set  
6 Aside Default Order and for Post Order Hearing, a copy of which  
7 is attached to this Order.

9 CONCLUSIONS OF LAW

11 1) WSC has not shown that their failure to request a hearing was  
12 due to mistake, inadvertence, surprise or excusable neglect.  
13 2) WSC has not set forth a meritorious defense to the matters  
14 set forth in the Final Order.

20 Conclusions of Law, WSC's Request To Set Aside Default Order And  
21 For Post Order Hearing is hereby **DENIED**.
