

1 2. Respondent conducts a consumer loan business and operates
2 from four locations in Oregon which are licensed pursuant to
3 the provisions of ORS 725.

4 3. Thomas C. Shauklas is the agent for service of process for
5 Respondent. Service may be made at 2929 SE Powell Boulevard,
6 Portland, Oregon 97202.

7 4. On February 4, 2004 an examination of the office at 20577
8 SW Tualatin Valley Highway in Aloha was conducted by Examiner
9 Larry Sisson. In the course of the examination, Examiner
10 Sisson observed procedures and omissions by OAK BROOK-DENNEY
11 LLC described as exceeding the maximum allowable rollovers or
12 extensions on title loans.

13 **CONCLUSIONS OF LAW**

14 The Director **CONCLUDES** that the Respondent renewed or extended
15 a title loan more than six times in violation of ORS
16 725.615(6).

17 **ORDER**

18 The Director **ORDERS** that:

19 1. Respondent shall **CEASE AND DESIST** from violations of ORS
20 chapter 725 and OAR chapter 441, division 730.

21 2. Respondent is assessed a **CIVIL PENALTY** in the amount of
22 Three Thousand Seven Hundred Fifty Dollars (\$3,750), all of
23 which is **SUSPENDED** indefinitely upon the following **CONDITIONS**:


24 a. Respondent shall comply with all requirements of this

11 Consumer Finance Law and related regulations.
