12 **Respondent.**

13 **WHEREAS**, the Director of the Department of Consumer and Business Services for the  
14 State of Oregon (hereafter "the Director"), acting pursuant to the authority contained in ORS  
15 697.005 to 697.095 (hereafter "the Collection Agency Laws"), has conducted an investigation  
16 into the activities of MARAUDER CORPORATION A CORPORATION OF CALIFORNIA.  
17 (hereafter "MARAUDER");

18 **WHEREAS**, on June 28, 2007 the Director issued Administrative Order No. CA-07-0019  
19 REVOKING REGISTRATION AND NOTICE OF RIGHT TO CONTESTED CASE HEARING  
20 (hereafter "the Order") against Respondent MARAUDER;

21 **WHEREAS** on July 2, 2007, the Respondent's registered agent, Corporation Service  
22 Company, was duly served with a true copy of the Order by certified United States mail (Item #  
23 7006 2760 0005 1582 2113), postage prepaid, addressed to Respondent MARAUDER in care of  
24 the registered agent at the following address: 285 Liberty Street NE, Salem, Oregon 97301.

25 Receipt of the Order was acknowledged by Tracy Wasson.

26 **WHEREAS** on July 2, 2007, the Respondent was duly served with a true copy of the  
Order by certified United States mail (Item # 7006 2760 0005 1582 2106), postage prepaid,  
addressed to Respondent MARAUDER, in care of Ryon Gambill, at the following address: 74923







1 expire on August 31, 2007.

2 4. On or about April 16, 2007, the Division received notice from Hartford that the  
3 bond for MARAUDER, bond number 14BSBDN4449, would be cancelled effective May 22,  
4 2007. A copy of that notice was also sent to MARAUDER.

5 5. On April 16, 2007, Division Program Specialist Ann Nakamura ("Nakamura")  
6 telephoned MARAUDER president Gambill to notify him of receipt of the bond cancellation  
7 notice from Hartford and to inquire whether bond number 14BSBDN4449 would be renewed or a  
8 new bond obtained. Gambill informed Nakamura that MARAUDER was in the process of  
9 obtaining a new bond and would have it in place by the time bond number 14BSBDN4449 was  
10 canceled. Nakamura also wrote a letter to Gambill that same day confirming the telephone  
11 conversation.

12 6. On May 29, 2007, Nakamura sent another letter to Gambill by fax and regular  
13 mail. In this letter, she reiterated the points of the April 16 telephone conversation and letter. She  
14 also reminded Gambill that he told her that MARAUDER would have a new bond in place by  
15 May 22, 2007. Nakamura informed Gambill that if a new bond were not in place by June 5, 2007,  
16 the Division would initiate revocation proceedings. MARAUDER failed to have a new bond in  
17 place by June 5, 2007.

18 7. To date, MARAUDER has not provided information or evidence to indicate that  
19 bond number 14BSBDN4449 was continued or replaced by another bond.

## 20 CONCLUSIONS OF LAW

21 The Director **CONCLUDES** that:

22 8. MARAUDER has violated ORS 697.031 by failing to continuously maintain in  
23 effect, since its initial registration in 2004, a bond or irrevocable letter of credit in the amount of  
24 at least ten thousand dollars (\$10,000.00).

25 9. Pursuant to ORS 697.039, the Director may refuse to issue or renew or may revoke  
26 or suspend any registration issued under ORS 697.031 if the Director determines that a person has

1 failed to maintain in effect the bond or irrevocable letter of credit required under ORS 697.031.


2 **ORDER**

3 The Director, pursuant to the authority of the Oregon Collection Agency Laws, including  
4 but not limited to ORS 697.039, hereby **ORDERS** that the Oregon collection agency registration  
5 of Respondent MARAUDER CORPORATION A CORPORATION OF CALIFORNIA is hereby  
6 **REVOKED.**

7 The entry of this Order in no way limits further remedies which may be available to the  
8 Director under Oregon law.
