FINAL ORDER REVOKING
REGISTRATION ENTERED BY
DEFAULT

10 **Respondent.**

11 **WHEREAS**, the Director of the Department of Consumer and Business Services for the
12 State of Oregon (hereafter "the Director"), acting pursuant to the authority contained in ORS
13 697.005 to 697.095 (hereafter "the Collection Agency Laws"), has conducted an investigation
14 into the activities of Sure Tech Recovery, LLC (hereafter Respondent or "SURE TECH");

15 **WHEREAS**, on July 26, 2007 the Director issued Administrative Order No. CA-07-0023
16 **REVOKING REGISTRATION AND NOTICE OF RIGHT TO A PUBLIC HEARING** (hereafter
17 "the Order") against Respondent SURE TECH;

18 **WHEREAS** on July 27, 2007, the Respondent's registered agent, National Registered
19 Agents, Inc., was duly served with a true copy of the Order by certified United States mail (Item #
20 7006 2760 0005 1582 2212), postage prepaid, addressed to Respondent SURE TECH in care of
21 the registered agent at the following address: 3533 Fairview Industrial Road SE, Salem, Oregon
22 97302. Receipt of the Order was acknowledged by K. Kaplan.

23 **WHEREAS** Respondent SURE TECH has not made a written request for a contested case
24 hearing in this matter and time to do so has expired.

25 **NOW THEREFORE**, after consideration of the Investigation Report and accompanying
26 exhibits submitted in this matter by Ann Nakamura, the Director, recognizing that the period for



1 these Respondents to request a hearing has passed, hereby issues the following Findings of Fact,
2 Conclusions of Law, and Final Order.

3 **FINDINGS OF FACT**

4 The Director **FINDS** that:

5 1. Sure Tech Recovery, LLC is a Nevada limited liability company with principal
6 offices located at 916 Nevada Hwy, Suite 10, Boulder City, Nevada 89005-2393. SURE TECH is
7 registered as a foreign limited liability company with the Oregon Secretary of State; SURE TECH
8 has no Oregon office. The company's Oregon registered agent is National Registered Agents,
9 Inc., 3533 Fairview Industrial Road SE, Salem, Oregon 97302. By information and belief, the
10 managing member of the company is Lee Milhollin, although the managing members listed in the
11 Oregon Secretary of State's records are Gary Fair and Jay King.

12 2. SURE TECH is registered to do business as a collection agency in Oregon having
13 been issued registration number CA 49009. SURE TECH was first registered with the Division
14 of Finance and Corporate Securities (hereinafter the "Division") as a collection agency on or
15 about September 24, 2003. As part of that application SURE TECH provided evidence of a bond,
16 number 3798481, in the amount of ten thousand dollars (\$10,000) through The Ohio Casualty
17 Insurance Company ("Ohio Casualty"). The bond was later increased to fifteen thousand dollars
18 (\$15,000) when the Division granted the company's request for a waiver of the requirement that it
19 have an Oregon office and client trust account location.

20 3. SURE TECH's Oregon collection agency registration was last renewed on October
21 2, 2006 and will expire on September 30, 2007.

22 4. On or about June 14, 2007, the Division received notice from Ohio Casualty that
23 the bond for SURE TECH would be cancelled effective July 14, 2007. A copy of that notice was
24 also sent to SURE TECH.

25 5. By letter dated June 22, 2007, the Division notified SURE TECH that it had
26 received notice of impending bond cancellation from Ohio Casualty and inquired whether the

1 current bond would be renewed or a new bond obtained. The Division received no response to
2 this letter.

3 6. To date, SURE TECH has not provided information or evidence to indicate that
4 the bond was continued or replaced by another bond.

5 **CONCLUSIONS OF LAW**

6 The Director **CONCLUDES** that:

7 7. SURE TECH has violated ORS 697.031 by failing to continuously maintain in
8 effect, since its initial registration in 2003, a bond or irrevocable letter of credit in the amount of
9 fifteen thousand dollars (\$15,000).

10 8. Pursuant to ORS 697.039, the Director may refuse to issue or renew or may revoke
11 or suspend any registration issued under ORS 697.031 if the Director determines that a person has
12 failed to maintain in effect the bond or irrevocable letter of credit required under ORS 697.031.

13 **ORDER**

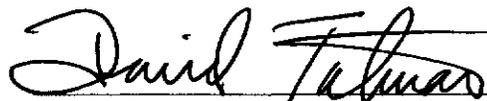
14 The Director, pursuant to the authority of the Oregon Collection Agency Laws,
15 including but not limited to ORS 697.039, hereby **ORDERS** that Respondent SURE
16 TECH's Oregon collection agency registration is hereby **REVOKED**.

17 The entry of this Order in no way limits further remedies which may be available to the
18 Director under Oregon law.
