FINAL ORDER REVOKING  
REGISTRATION ENTERED  
BY DEFAULT**

On or about August 24, 2009, the Director of the Department of Consumer and Business Services for the State of Oregon (hereinafter "the Director") acting by the authority of the Oregon Collection Agency Laws, Oregon Revised Statutes 697.005 to 697.095 and other applicable authority, issued Administrative Order No. CA-09-0026, ORDER REVOKING REGISTRATION AND NOTICE OF RIGHT TO A PUBLIC HEARING (hereinafter "the Proposed Order") against Respondent, Argyle Solutions Inc.

On August 24, 2009, Argyle Solutions Inc. (hereinafter "Respondent") was duly served with a true copy of the Proposed Order by regular, first-class mail and by certified mail, postage prepaid, addressed to 7880 Bent Branch Suite 150, Irving, Texas and addressed to Respondent's registered agent, C T Corporation System, 388 State Street Suite 420, Salem Oregon 97301.

A green card from the order sent to C T Corporation System, 388 State Street Suite 420, Salem Oregon 97301 was signed and returned on August 25, 2009. On or about August 27, 2009, CT Corporation sent a letter to the Director returning the documents received for Respondent because their statutory representation services were discontinued and all process sent to the last

1 known address on their records and was returned as undeliverable.

2 Green cards from the orders sent by certified mail to both addresses were signed and  
3 returned. Respondent has not made a written request for a contested case hearing in this matter  
4 and time to do so has expired.

### 5 FINDINGS OF FACT

6 The Director **FINDS** that:

7 1. Respondent is a foreign business corporation with principal offices located at 255 Great  
8 Arrow Avenue, Second Floor, Suite 15, Buffalo, New York 14207. Respondent is registered as  
9 an active New York foreign business corporation with the Oregon Secretary of State. Respondent  
10 has no Oregon office. The Oregon registered agent for Respondent listed with the Secretary of  
11 State is Lexis Document Services Inc., 285 Liberty Street, Northeast, Salem Oregon 97301.

12 2. Respondent is registered to do business as a collection agency in Oregon having been  
13 issued registration number CA 49008. Respondent was first registered with the Division of  
14 Finance and Corporate Securities (hereinafter the "Division") as a collection agency on or about  
15 September 18, 2003.

16 3. As part of that application, Respondent provided evidence of a \$15,000 surety bond with  
17 International Fidelity Insurance Company (hereinafter "International Fidelity") as the insurer.  
18 Coverage was continuous.

19 4. Respondent's Oregon collection agency registration was last renewed on September 17,  
20 2008 and will expire September 30, 2009.

21 5. The Division received a notice from International Fidelity on March 2, 2009, that the bond  
22 would be cancelled effective 30 days from the receipt of notice.

23 6. On or about March 3, 2009, a Division Collection Agency Program Specialist attempted to  
24 contact Respondent regarding the bond cancellation notice, but the telephone number Respondent  
25 provided to the Division had been disconnected.



1 7. By letter dated March 3, 2009, the Division notified Respondent that it had received notice  
2 of impending bond cancellation and inquired whether the current bond would be renewed or a  
3 new bond obtained. No response was received.

4 8. By letter dated March 23, 2009, a second notice of bond cancellation was sent to  
5 Respondent. The letter requested Respondent to contact the Division upon receipt of the mailing,  
6 and to date, no response has been received.

7 9. To date, Respondent has not provided information or evidence to indicate that the bond  
8 was continued or replaced by another bond.

9 **CONCLUSIONS OF LAW**

10 The Director **CONCLUDES** that:

11 1. Respondent has violated ORS 697.031(2)(a) by failing to continuously maintain in  
12 effect, since its initial registration in 2006, a bond or irrevocable letter of credit in the amount of  
13 Ten Thousand Dollars (\$10,000).

14 2. Pursuant to ORS 697.039(1)(d), the Director may refuse to issue or renew or may  
15 revoke or suspend any registration issued under ORS 697.031 if the Director determines that a  
16 person has failed to maintain in effect the bond or irrevocable letter of credit required under ORS  
17 697.031.

18 **ORDER**

19 The Director, pursuant to the authority of the Oregon Collection Agency Laws,  
20 including but not limited to ORS 697.039, hereby **ORDERS** that the collection agency  
21 registration for Respondent is hereby **REVOKED**.
