



1 sale of manufactured structures without a license. The Department employee
2 also provided the Division with a copy of a contract for the sale of a manufactured
3 structure entered into between Respondent and a consumer on or about January
4 17, 2008.

5 4. On or about June 24, 2009 a Division employee contacted Respondent and
6 requested that they provide the Division a report of all potential unlicensed sales
7 in which they had engaged by no later than July 13, 2009.

8 5. On or about July 6, 2009 Respondent's representative replied by faxed letter,
9 stating that they had engaged in two sales of manufactured structures in 2009,
10 while unlicensed. The letter did not contain any reference to sales conducted
11 prior to 2009.

12 6. Respondent subsequently obtained a Manufactured Structures Dealer's License
13 that became effective on July 22, 2009.

14 7. At all times relevant to the three sales discussed in paragraphs 3 and 5, *infra*,
15 Respondent did not have a license to engage in the sale of manufactured
16 structures.

17
18 **CONCLUSIONS OF LAW**

19 The Director **CONCLUDES** that:

20 1. Respondent violated ORS 446.671 at least three times by engaging in the sale of a
21 manufactured structure in Oregon without a license.

22 **ORDER**

23 **NOW, THEREFORE, THE DIRECTOR ISSUES THE FOLLOWING ORDERS:**

24 The Director, pursuant to ORS 446.995, hereby **ORDERS** Respondent to pay the
25 State of Oregon a civil penalty of \$500 for each of three violations of ORS 446.671, for a
26 total **CIVIL PENALTY of \$1500.**

1 The date of this Order is the day the Director or Director's nominee signs the
2 Order. The entry of this Order does not affect or limit in any manner the Director's
3 ability to invoke further remedies, specifically including but not limited to assessing civil
4 penalties or denying, suspending, conditioning or revoking a license, which may be
5 available to the Director under Oregon law based upon the violation(s) noted in this
6 Order or any other violation.
