**Final Order to Cease and Desist and
Order Assessing Civil Penalties

On May 23, 2011, the Director (the “Director”) of the Department of Consumer and Business Services (the “Department”), acting by authority of Oregon Revised Statutes (“ORS”) 86A.100 et seq. (the “Oregon Mortgage Lender Law”), issued Administrative Order M-11-0020, Order to Cease and Desist, Order Assessing Civil Penalties, and Notice of Right to Hearing (the “Proposed Order”) against Blue Coast Home Loans Inc. (the “Respondent”).

On May 24, 2011, Respondent was mailed true copies of the Proposed Order by regular, first-class mail and by certified mail, postage prepaid, return receipt requested, and addressed to the mailing address of record in the Nationwide Mortgage Licensing System for Blue Coast Home Loans, which is 10421 Ballard Drive, in Garden Grove, California 92840. The United States Post Office provided notice of the certified mail to Respondent on May 28, 2011, but Respondent has not responded to that notice. The Proposed Order mailed by regular mail has not been returned to the Department.

In addition, on May 24, 2011, the Oregon Agent for Service of Process for Respondent was mailed true copies of the Proposed Order by regular, first-class mail and by certified mail, postage pre-paid, return receipt requested, and addressed to Blue Coast Home Loans c/o National Registered Agents Inc. at 325 13th St. NE, Salem, Oregon, 97301. The certified mail was delivered and signed for on May 26, 2011. The Proposed Order mailed by regular mail has not been returned to the Department.

1 Respondent has not made a written request for a contested case hearing in this matter and
2 the time to do so has expired.

3 Now therefore, after consideration of the Department's investigative file and the related
4 documents, the Director hereby issues the following Findings of Fact, Conclusions of Law and
5 Final Order.

7 **FINDINGS OF FACT**

8 The Director **FINDS** that:

9 1. Respondent held a license to engage in Oregon residential mortgage lending in 2010.

10 2. ORS 86A.112(3) requires that the Department's Division of Finance and Corporate
11 Securities (the "Division") obtain from licensed Oregon mortgage bankers and brokers annual
12 reports concerning their residential mortgage lending activities. Oregon Administrative Rule
13 ("OAR") 441-865-0025 defines the data required to be included in those reports and sets the
14 deadline for filing them. The deadline for filing mortgage lending annual reports with the
15 Division for business conducted in 2010 was March 31, 2011.

16 3. By January 4, 2011, the Division made public a website located at
17 <https://www4.cbs.state.or.us/exs/dfcs/mlrpt/index.cfm> for licensees to use to file their annual
18 reports. The Division posted a link to that website from the Division home page along with
19 information on the annual report requirement. In addition, the Mortgage Lender home page also
20 contained a prominent notice.

21 4. On January 20, 2011, all firms that held a mortgage lender license as of that day were
22 sent an e-mail that, inter alia, reminded the companies of the obligation to file the annual report
23 by March 31, 2011.

24 5. By letter dated February 3, 2011, all firms that held a mortgage lending license in Oregon
25 in 2010 were notified of the requirement to file the 2010 annual report by March 31, 2011.

26 6. On February 3, 2011, a Division employee sent an e-mail to all companies that were





1 required to file the report for which it had a valid e-mail address, reminding them of the
2 requirement to file the annual report.

3 7. On March 1, 2011, a Division employee sent another reminder e-mail to those companies
4 that had not yet filed an annual report, for which it had valid e-mail addresses.

5 8. On March 14, 2011, a Division employee sent another reminder e-mail to those
6 companies that had not yet filed an annual report, for which it had valid e-mail addresses.

7 9. On March 28, 2011, a Division employee sent another reminder e-mail to those
8 companies that had not yet filed an annual report, for which it had valid e-mail addresses.

9 10. On April 1, 2011, a Division employee sent reminder letters to all the companies that
10 have current mortgage lender licenses in Oregon and had a license in 2010, but had not yet filed
11 an annual report. The letter reminded the licensees of the obligation to file an annual report,
12 informed them again of the \$100 penalty per day for failure to file the report and noted that the
13 Mortgage Lending Section would be forwarding those companies who had not filed the annual
14 report by May 1, 2011 to the Enforcement Section for the enforcement of the civil penalty.

15 11. As of May 2, 2011, the Division had not received an annual report from Respondent.

17 CONCLUSION OF LAW

18 1. By failing to file the 2010 annual report with the Director by March 31, 2011, Respondent
19 violated ORS 86A.112(3) and OAR 441-865-0025.

21 ORDER

22 **NOW, THEREFORE, THE DIRECTOR ISSUES THE FOLLOWING ORDERS:**

23 The Director, pursuant to her authority under ORS 86A.115, ORS 86A.127, and ORS
24 86A.118, hereby **ORDERS** that Respondent shall **CEASE AND DESIST** from violating any
25 provision of Oregon Mortgage Lender Law, OAR 441-850-0005 through 441-885-0010 and any
26 rule, order or policy issued by the Division; **AND**

1 The Director, pursuant to ORS 86A.992 and ORS 86A.118 hereby **ORDERS** Respondent
2 to pay the State of Oregon a civil penalty of **\$3,200.00**. The civil penalty is based on a fine of
3 \$100.00 per day for each day after March 31, 2011 through and including May 2, 2011 on which
4 Respondent failed to file an annual report.
