(“Oregon Manufactured Structure Dealers and Dealerships Law”); and

WHEREAS Gail McNally wishes to resolve and settle this matter with the Director;
NOW THEREFORE, as evidenced by the authorized signatures subscribed on this Consent Order, Gail McNally hereby consents to entry of this order upon the Director’s Findings of Fact and Conclusions of Law as stated hereinafter:

FINDINGS OF FACT

1. Based on a search of the Division’s records on April 4, 2013, Gail McNally has been licensed with the Division as a Manufactured Structure Dealer at all times material save and except the period from February 4, 2012, to June 6, 2012. She became unlicensed on February 4, 2012 when her bond lapsed.
