9 On March 17, 2015, the Director of the Department of Consumer and Business  
10 Services for the State of Oregon (the “Director”), acting under the authority of the  
11 Oregon statutes regulating collection agencies, ORS 697.005 to 697.095, and  
12 administrative rules promulgated thereunder, and ORS 183.415(3), duly served Too Late  
13 Collection LLC with a true copy of Administrative Order CA-15-0013, PROPOSED  
14 ORDER REFUSING TO ISSUE AN OREGON COLLECTION AGENCY  
15 REGISTRATION AND NOTICE OF RIGHT TO AN ADMINISTRATIVE HEARING  
16 (the “Notice Order”).

17 In accordance with OAR 137-003-0075, the Notice Order designated the  
18 Division’s file, including any materials submitted by Too Late Collection LLC, as the  
19 record for the purpose of making a prima facie case in the event that the Director entered  
20 a final order by default.

21 Too Late Collection LLC did not timely request a hearing.

22 Now, therefore, on consideration of the record, the Director issues the following  
23 Findings of Fact, Conclusions of Law and Final Order.
