FINAL ORDER TO CEASE AND
DESIST, FINAL ORDER
ASSESSING CIVIL PENALTY,
AND CONSENT TO ENTRY OF
ORDER

The Director of the Department of Consumer and Business Services for the State of Oregon (hereinafter “the Director”), acting in accordance with the Oregon Securities Law, Oregon Revised Statutes (“ORS”) 59.005 to 59.451, 59.991 and 59.995, and Oregon Administrative Rules (“OAR”) chapter 441, has investigated the securities salesperson (“salesperson”) license application, and the amendments thereto, of Justin Pike (“Respondent”).

Respondent has cooperated with the Director’s investigation and wishes to resolve this matter with the Director;

Now, therefore, as evidenced by the signature subscribed herein, Respondent hereby CONSENTS to the entry of this Order.

FINDINGS OF FACT

The Director FINDS that:

1. Respondent is licensed in Oregon to work as a salesperson for a broker-dealer. The Central Registration Depository (“CRD”) number for Respondent is #4677340.
2. In order to become licensed as a salesperson in Oregon, Respondent was required to complete the CRD Uniform Application for Securities Industry Registration



1 or Transfer (“Form U-4”). The Form U-4 includes Disclosure Questions, wherein
2 Respondent was required to disclose certain information identified therein, including, but
3 not limited to, the “Financial Disclosure” information set forth in Question 14M of the
4 application. Respondent, as a licensee, has a responsibility to keep the information in the
5 application, including the financial disclosure information, continually updated.

6 3. As part of the salesperson licensing process in Oregon, Respondent completed
7 a Form U-4, including the Financial Disclosure section of the form, on or about
8 November 14, 2011. Respondent became licensed in Oregon as a salesperson on or about
9 November 14, 2011.

10 4. Question 14M of the Form U-4 asks: “Do you have any unsatisfied judgments
11 or liens against you?”

12 5. On January 9, 2012, a judgment was filed against the Respondent in
13 Snohomish County, Washington.

14 6. Respondent did not disclose the above-described judgment on his license
15 application, in response to Question 14M of Form U-4, until October 9, 2012, more than
16 30 days from the date of occurrence.

17 7. The judgment was released on December 27, 2012.

18 CONCLUSIONS OF LAW

19 The Director CONCLUDES that:

20 8. Respondent is licensed as a “salesperson” in Oregon, as defined by ORS
21 59.015(18)(a).

22 9. Respondent, as a licensed salesperson, is required to amend his license
23 application on Form U-4 “when there are material changes in the information contained
24 in the original application.” ORS 59.175(6); OAR 441-175-0105(3)(c).

25 10. In accordance with OAR 441-175-0105(2), Respondent is required to amend

1 his Oregon license application within 30 days of the occurrence of any material changes
2 in the information contained in the original application or any amendments thereto.

3 11. Question 14M of the Form U-4, "Financial Disclosure," requires that a
4 licensed salesperson disclose an unsatisfied judgment.

5 12. The entry of the judgment against the Respondent is a "material change" of
6 the information contained in the original application, as that term is used in ORS
7 59.175(6) and OAR 441-175-0105(2).

8 13. Respondent failed to timely file an amendment to his Oregon salesperson
9 license application within 30 days of the occurrence of a material change, in violation
10 ORS 59.175(6) and OAR 441-175-0105(2).

11
12 **ORDERS**

13 The Director issues the following ORDERS:

14 *Final Order to Cease and Desist*

15 14. In accordance with ORS 59.245, Respondent is hereby ORDERED to CEASE
16 AND DESIST from:

17 A. Failing to timely file a required amendment to his Oregon salesperson license
18 application after a material change to the information contained in the application, as
19 required by ORS 59.175(6) and OAR 441-175-0105(2); and

20 B. Violating any provision of Oregon Revised Statutes chapter 59 or Oregon
21 Administrative Rules chapter 441.

22 *Final Order Assessing Civil Penalty*

23 15. In accordance with ORS 59.995, the Director may assess CIVIL PENALTIES
24 in an amount not to exceed \$20,000 per violation against persons who violate the Oregon
25 Securities Law. In the case of a continuing violation, each day's continuance is a separate
26 violation, but the maximum penalty for any continuing violation shall not exceed



1 \$100,000.

2 16. In accordance with ORS 59.995(1), the Director hereby ORDERS Respondent
3 to pay a CIVIL PENALTY in the total amount of \$5,000 for violations of ORS 59.175(6)
4 and OAR 441-175-0105(2).

5 17. The Director SUSPENDS the collection of \$4,000 of the civil penalty
6 assessed above, so long as Respondent complies with all terms and conditions of this
7 Order and all requirements of the Oregon Securities Law. If Respondent complies with
8 the terms of this Order and the Director has not initiated an enforcement action for new
9 violations of the Oregon Securities Law during the three-year period from the effective
10 date of this Order, the Director WAIVES the collection of the suspended CIVIL
11 PENALTY assessed herein.

12 18. Respondent must pay \$1,000 of the civil penalty at signing, prior to the entry
13 of this Order.

14 19. The Director reserves the right to immediately take enforcement action,
15 pursuant to the procedures set forth in ORS 183.745, to impose the suspended CIVIL
16 PENALTY if Respondent violates any term of this Order.

17 20. This Order is a “Final Order” under ORS 183.310(6)(b). Subject to that
18 provision, the entry of this Order does not limit other remedies that are available to the
19 Director under Oregon law.
