

	4	10. Because Alpha violated ORS 742.554(2) and OAR 836-080-0240(4), the
	5	Director is authorized by ORS 731.252(1) to order Alpha to cease and desist from
	6	violating those statutes and rules.
	7	11. ORS 731.988(1) authorizes the Director to assess a \$10,000 civil penalty
	8	against Alpha for each of its violations of the Insurance Code.
	9	ORDERS
	10	Now therefore, the Director issues the following Orders:
	11	Order to Cease and Desist
	12	12. As authorized by ORS 731.252(1), the Director ORDERS Alpha to CEASE
	13 14	AND DESIST from violating ORS 742.554(2) and OAR 836-080-0240(4).
	14	Order Assessing Civil Penalties
	16	13. As authorized by ORS 731.988(1), the Director ORDERS Alpha to pay
