THIS IS A FINAL ORDER

The Director of the Department of Consumer and Business Services for the State of Oregon ("Director"), acting in accordance with Oregon Revised Statutes ("ORS") 731, 732, 733, 734, 735, 737, 742, 743, 743A, 743B, 744, 746, 748 and 750 ("Insurance Code"), and specifically 735.530 to 735.552, has determined that Drexi, Inc. ("Drexi") engaged in activities that violated ORS 735.530 to 735.552.

Drexi wishes to resolve and settle this matter with the Director.

Now, therefore, as evidenced by the authorized signatures subscribed on this Order, Drexi CONSENTS to entry of this Order upon the Director's Findings of Fact and Conclusions of Law as stated hereinafter.

FINDINGS OF FACT

The Director FINDS that:

- 1. Drexi is a Delaware corporation with its principal place of business at 35 Technology Parkway South, Suite 100, Peachtree Corners, GA 30062.
- 2. Drexi began operating as a pharmacy benefit manager ("PBM") in Oregon in 2016. From 2016 through September of 2022, Drexi operated as a PMB in Oregon without registering as a PMB with the Department of Consumer and Business Services ("Department").

CONCLUSIONS OF LAW

The Director CONCLUDES that:

- 5. Pursuant to ORS 731.252 (1), if the director has reason to believe that a person has violated, is violating, or is about to violate the Insurance Code the Director may issue an order to cease and desist from the violation.
- Pursuant to ORS 735.532 (1), a PBM "must register with the Department of 6. Consumer and Business Services and annually renew the registration."
- 7. Drexi violated ORS 735.532 (1) from 2016 through September of 2022 by failing to register as a PMB with the Department.
- 8. Pursuant to ORS 731.988 (1), a person who violates any provision of the Insurance Code is subject to forfeiture and payment of a civil penalty in an amount of not more than \$10,000 for each offense.

ORDERS

Now therefore, the Director issues the following Orders:

- As authorized by ORS 731.252 (1), the Director ORDERS Drexi to CEASE AND DESIST from violating ORS 735.532 (1).
- As authorized by ORS 731.988 (1), the Director hereby imposes CIVIL 10. PENALTIES against Drexi in the amount of \$23,100 for violating of ORS 735.532 (1) in the calendar years 2016 through 2022.
- The Director hereby SUSPENDS \$11,550 of the CIVIL PENALTY imposed against Drexi for a period of three years from the effective date of this Order, provided Drexi complies with the forgoing Order terms and does not commit any further violations of the Insurance Code during the three year period.
