STIPULATION

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Progressive Northern Insurance Company (Progressive Northern).

Progressive Northern desires to conclude this proceeding without a hearing by entering into this stipulation pursuant to ORS 183.415(5).

Progressive Northern waives all rights relative to an administrative hearing and judicial review thereof.

Progressive Northern stipulates to the following facts, conclusions, action, and to the issuance of a final order incorporating this stipulation.

Facts and Conclusions

Licensing Information

Progressive Northern has been licensed in Oregon as a foreign insurer since 9/19/89. Progressive Northern's last recorded principal business address is located in Mayfield Village, Ohio.

Failed to Acknowledge and Act Promptly Upon Communication About Claim

Progressive Northern is subject to enforcement action pursuant to ORS 746.230(1)(b) because of the following circumstances. ORS 746.230(1)(b) prohibits an insurer from failing to acknowledge and act promptly upon communications relating to claims. On 8/29/04, Yancy Lima, Santos Lima, Gloria Lima, and Santos "Tito" Lima Jr. (collectively referred to as Lima) were riding as passengers in a motor vehicle driven by Erik Virrueta (Virrueta) and owned by Billy Martinez (Martinez). Virrueta lost control of the vehicle and went off the roadway.

Lima was injured and incurred medical expenses as a result of the accident. Lima was received health benefits from the Oregon Health Plan through the InterCommunity Health Plans, Inc. (ICHP). Virrueta was insured under an automobile insurance policy issued to Martinez by Progressive Northern, an insurer. On 9/17/04, ICHP faxed to Progressive Northern a letter informing Progressive Northern that ICHP "had provided or may provide healthcare services to the Lima family for injuries sustained in this accident," and requesting Progressive Northern "confirm that Progressive provides liability coverage for this accident." On the same date, 9/17/04, Progressive Northern received the letter but did not respond. On 11/18/04, ICHP mailed to Progressive Northern a follow up letter asking for a response. On 11/22/04, Progressive Northern received the letter but did not respond. On 12/16/04, ICHP faxed to Progressive Northern another follow up letter asking for a response. On the same date, 12/16/04, Progressive Northern received the letter but did not respond. On 2/24/05, ICHP faxed to Progressive Northern another follow up letter asking for a response. On the same date, 2/24/05, Progressive Northern received the letter but did not respond. On 4/15/05, ICHP mailed to Progressive Northern another follow up letter asking for a response. On 4/19/05, Progressive Northern received the letter but did not respond. On 5/25/05, ICHP mailed to Progressive Northern another follow up letter asking for a response. On 5/31/05, Progressive Northern received the letter but did not respond. Finally, on 7/21/05, Progressive Northern sent a letter to ICHP saying "[t]his will acknowledge your request for reimbursement. At which time the claims for the above captioned individuals are ready to be settled, I will protect your client's subrogated interests in accordance with the applicable ORS statutes." Thus, Progressive Northern received, but failed to respond to, five claim inquiry letters dated 9/17/04, 11/18/04, 12/16/04, 2/24/05, and 4/15/05.

Action

Pursuant to ORS 731.988, Progressive Northern is assessed a civil penalty of \$10,000. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The

payment shall be delivered to the Insurance Division at the Labor and Industries Building, 350 Winter Street NE, Room 440 (4th Floor), Salem, Oregon; or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be *received* by the Insurance Division by the date of the final order.
