STIPULATION

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Virginia Surety Company, Inc. (Virginia Surety).

Virginia Surety desires to conclude this proceeding without a hearing by entering into this stipulation pursuant to ORS 183.415(5).

Virginia Surety waives all rights relative to an administrative hearing and judicial review thereof.

Virginia Surety stipulates to the following facts, conclusions, action, and to the issuance of a final order incorporating this stipulation.

Facts and Conclusions

Licensing Information

Virginia Surety has been licensed in Oregon as a foreign insurer since 6/30/82. Virginia Surety's last recorded principal business address is located in Glenview, Illinois.

Increased Special Workers' Compensation Deposit Late

Virginia Surety is subject to enforcement action pursuant to ORS 731.616(3) because of the following circumstances. ORS 731.616(3) requires a person who is licensed in Oregon as an insurer, is authorized to transact workers' compensation insurance, and is subject to ORS 731.628, to make and maintain a special deposit for the payment of workers' compensation benefits, and to deposit with the director an additional amount within 30 days after being notified by the director of the amount. On 5/14/07, the director notified Virginia Surety that it was required to

make an additional deposit of \$296,072 to its special workers' compensation deposit by 6/13/07. However, Virginia Surety made the additional deposit on 8/13/07, 61 days late.

Action

Pursuant to ORS 731.988, Virginia Surety is assessed a civil penalty of \$6,100. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at the Labor and Industries Building, 350 Winter Street NE, Room 440 (4th Floor), Salem, Oregon; or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be *received* by the Insurance Division by the date of the final order.
