STIPULATION

The Director of the Oregon Department of Consumer and Business Services (director) commenced this administrative proceeding, pursuant to Oregon Revised Statutes (ORS) 731.256, to take enforcement action against Presidential Life Insurance Company (Presidential Life).

Presidential Life desires to conclude this proceeding without a hearing by entering into this stipulation pursuant to ORS 183.415(5).

Presidential Life waives all rights relative to an administrative hearing and judicial review thereof.

Presidential Life stipulates to the following facts, conclusions, action, and to the issuance of a final order incorporating this stipulation.

Facts and Conclusions

<u>Licensing Information</u>

Presidential Life has been licensed in Oregon as a foreign insurer since 11/15/75. Presidential Life's last recorded principal business address is located in Nyak, New York.

<u>Issued Group Health Insurance Policy to Unapproved Association</u>

Presidential Life is subject to enforcement action pursuant to ORS 743.524(1) because of the following circumstances. ORS 743.524(1) prohibits an insurer from offering a group health insurance policy to an association as the policyholder or from offering coverage under such a policy, whether issued in this or another state, unless the director determines that the association satisfies the requirements of ORS 743.522. On 1/1/07, Presidential Life issued a group health insurance policy to

the Direct Services Association which was not approved by the director, and insured under the policy 20 persons residing in Oregon.

Action

Pursuant to ORS 731.988, Presidential Life is assessed a civil penalty of \$5,000. The payment shall be made in the form of a check payable to the "Department of Consumer and Business Services" for the full amount due. The payment shall be delivered to the Insurance Division at the Labor and Industries Building, 350 Winter Street NE, Room 440 (4th Floor), Salem, Oregon; or mailed to the Insurance Division at PO Box 14480, Salem, OR 97309-0405. The payment shall be *received* by the Insurance Division by the date of the final order.
