WHEREAS the Director of the Department of Consumer and Busin for the State of Oregon (hereinafter "the Director") conducted an investigation of World Lending Group Inc formerly known as WMA Mortgage Services Inc, and determined that World Lending Group Inc formerly known as WMA Mortgage Services Inc engaged in activities constituting violations of ORS 59.840 through 59.965 (hereinafter "the Oregon Mortgage Lender Law"); and

WHEREAS World Lending Group Inc formerly known as WMA Mortgage Services Inc wishes to resolve and settle this matter with the Director;

NOW THEREFORE, as evidenced by the authorized signatures subscribed on this order World Lending Group Inc formerly known as WMA Mortgage Services Inc hereby CONSENTS to entry of this order upon the Director's Findings of Fact and Conclusions of Law as stated hereinafter:

FINDINGS OF FACT

The Director FINDS that:

(hereinafter "Respondent"), incorporated in Georgia on March 26, 1992 engages in residential mortgage transactions in Oregon or on Oregon real property in expectation of compensation. Respondent is 100% owned by Andrew J Woodman Jr and has been continuously licensed by the Director since December 11, 1996.

- 2. On September 5, 2002, a caller notified the Director that the Respondent no longer had open branches in Oregon.
- 3. On September 9, 2002, the Respondent confirmed in a phone conversation that the Portland and Lake Oswego Oregon branches had been previously closed and there were currently no loan originators employed.
- 4. On September 9, 2002, the Respondent sent a facsimile notification to the Director that the Portland and Lake Oswego Oregon branches closed effective June 1, 2002 and to terminate all persons registered as loan originators (70).

CONCLUSIONS OF LAW

The Director **CONCLUDES** that:

- 1. Respondent violated ORS 59.850(7) and OAR 441-860-0070(1)(h) by failing to notify the Director of the closure of two branch offices within 30 days of the occurrence.
- 2. Respondent violated OAR 441-860-0070(1)(g) and 441-880-0030(2) by failing to notify the Director of persons ending functioning as a loan originator within 30 days.

ORDER

The Director, pursuant to ORS 59.885(4), hereby ORDERS that World Lending Group Inc formerly known as WMA Mortgage Services Inc will CEASE AND DESIST from violating any provision of Oregon Mortgage Lender Law, OAR 441-850-0005 234 through 441-885-0010 and any rule, order, or policy issued by the Division.

The Director, pursuant to ORS 59.996 hereby ORDERS World Lending Group Inc formerly known as WMA Mortgage Services Inc to pay the State of Oregon a civil penalty of \$10,000.00.
