TIFICATION, ORDER ING CIVIL PENALITES AND 9 NOTICE OF RIGHT TO APPEAL 10 On October 14, 2014, the Director of the Department of Consumer and Business 11 Services for the State of Oregon (the "Director"), acting under the authority of the 12 statutes governing prearrangement and preconstruction sales contracts for funeral or 13 cemetery merchandise of services, Oregon Revised Statutes ("ORS") 97.923 to 97.949, 14 and the administrative rules promulgated thereunder, and ORS 183.415(3), duly served 15 Westrum Funeral Services, Inc. with a true copy of Administrative Order S-14-0049, 16 ORDER TO CEASE AND DESIST, PROPOSED ORDER SUSPENDING CERTIFIED 17 PROVIDER CERTIFICATION, PROPOSED ORDER ASSESSING CIVIL 18 PENALTIES AND NOTICE OF RIGHT TO AN ADMINISTRATIVE HEARING (the 19 "Notice Order"). 20 In accordance with OAR 137-003-0075, the Notice Order designated the 21 Division's file, including all materials submitted by Westrum Funeral Services, Inc., as 22 the record for the purpose of making a prima facie case in the event that the Director

Westrum Funeral Services, Inc. did not timely request a hearing.

Now, therefore, on consideration of the record, the Director issues the following Findings of Fact, Conclusions of Law and Final Orders.

I. FINDINGS OF FACT

The Director FINDS that:

- 1. The Division of Finance and Corporate Securities (the "Division") is the agency authorized by the Director to enforce Oregon's prearrangement and preconstruction sales contracts statutes, ORS 97.923 to 97.949.
- 2. Westrum Funeral Services, Inc. ("Westrum") is an Oregon corporation with a principal place of business located at 225 N. Birch Street, Coquille, OR 97423.
- 3. Westrum operates the following five certified provider locations (collectively the "Locations"):
 - A. Amling/Schroeder Funeral Service, Coquille Chapel, 225 N. Birch St.,
 Coquille, OR 97423, Certified Provider #0108;
 - B. Dunes Memorial Chapel, 2300 Frontage Rd., Reedsport, OR 97467,Certified Provider #0138;
 - C. Amling/Schroeder Funeral Service, Bandon Chapel, 125 SW 8th Ave.,
 Bandon, OR 97411, Certified Provider #0177;
 - D. Amling/Schroeder Funeral Service, Myrtle Point Chapel, 404 7th St.,
 Myrtle Point, OR 97458, Certified Provider #0178; and
 - E. Myrtle Grove Funeral Service, 94105 Rink Creek Land, Coquille, OR97423, Certified Provider #0365.
- 4. Westrum is certified by the Director as a "certified provider" at each of the Locations, as that term is defined in ORS 97.923, thereby permitting Westrum to sell, offer for sale, administer, or provide merchandise or services to fulfill prearrangement sales contracts or preconstruction sales contracts for funeral or cemetery merchandise or services.
- 5. Under ORS 97.933(1) and Oregon Administrative Rule ("OAR") 441-930-0270(1), a certified provider is required to pay an annual renewal fee to the Director in

the amount of \$390. Westrum is a separate certified provider at each of the Locations for
purposes of the annual renewal fee.

- 6. Furthermore, pursuant to ORS 97.933(3)(a) and OAR 441-930-0250, a certified provider is required to file an annual report with the Director on or before April 1 of each year, covering the preceding calendar year, and otherwise comply with OAR 441-930-0250(1)-(9).
- 7. Pursuant to OAR 441-930-0250, Westrum was required to pay the 2014 annual renewal fees of \$390 for each of the Locations, totaling \$1,950, and to file the 2013 annual reports for each of the Locations, on or before April 1, 2014.
- 8. Westrum failed to pay the required \$1,950 in certified provider renewal fees for 2014, and failed to file the required 2013 annual reports, on or before April 1, 2014.
- 9. Pursuant to ORS 97.945(1), Westrum was required to file a Funeral and Cemetery Consumer Protection Trust Fund Certified Provider Annual Contract Sale Report (the "Sales Report") for each of the certified provider Locations for 2013, wherein Westrum was required to identify all prearrangement sales contracts or preconstruction sales contracts entered into in 2013. Westrum was further required to pay a \$5 fee for each of the sales contract entered into in 2013. The 2013 Sales Reports and associated fees were due to the Director no later than January 31, 2014.
- 10. Westrum failed to file the required Sales Reports, and failed to pay the associated sales contract fees, on or before January 31, 2014 for four of the five Locations.

II. CONCLUSIONS OF LAW

The Director CONCLUDES that:

11. In accordance with ORS 97.948(1) and (2), OAR 441-930-0290, and OAR 441-930-0310, the Director may suspend the certification of a certified provider if the

Director determines that the certified provider has violated any provision of ORS 97.923
to 97.949, including, but not limited to, failing to pay the annual certification renewal fee
required by ORS 97.933 and OAR 441-930-0270, failing to submit an annual report
required by ORS 97.933 and OAR 441-930-0250, or failing to file the Sales Report and
pay the associated sales contract fees required by ORS 97.945(1).

- 12. In accordance with ORS 97.948(3), the Director may impose conditions for reinstatement of the certification, thereby identifying the activities that the certified provider is prohibited from engaging in during the suspension term and prior to reinstatement.
- 13. In accordance with ORS 97.948(2)(f) and (g), the Director may issue an order against a certified provider to cease and desist from the activities that support the suspension, and may assess civil penalties against a certified provider in an amount not to exceed \$10,000 per violation.
- 14. Westrum failed to pay the 2014 annual certification renewal fees of \$390 for each of the Locations, for a total of \$1,950, in violation of ORS 97.933(1) and OAR 441-930-0270(1).
- 15. Westrum failed to file 2013 annual reports with the Director for each of the Locations, in violation of ORS 97.933(3)(a) and OAR 441-930-0250.
- 16. Westrum failed to file 2013 Sales Reports with the Director for four of the five Locations, and failed to pay the fee of \$5 for each prearrangement sales contract or preconstruction sales contract entered into at the Locations during 2013, in violation of ORS 97.945(1).

III. ORDERS

The Director ISSUES the following ORDERS:

17. As authorized by ORS 97.948(2)(f), the Director hereby ORDERS Westrum, and all entities owned or controlled by Westrum, their successors and assignees, to CEASE AND DESIST from violating any provision of ORS 97.923 to 97.949, or any administrative rule adopted by the Director under those statutes.

Order Suspending Certified Provider Certification

18. As authorized by ORS 97.948(2)(b), OAR 441-930-0290 and OAR 441-930-0310, the Director hereby ORDERS that the certified provider certification for Westrum and its Locations, and any affiliated and/or successor person, business or company of Westrum, is SUSPENDED for a period of thirty (30) days from the date of issuance of this Final Order (the "Suspension Period").

Order Assessing Civil Penalties

- 19. As authorized by ORS 97.948(2)(g), the Director may assess CIVIL PENALTIES against certified providers that violate the provisions of ORS 97.923 to 97.949, or any administrative rules adopted thereunder, in an amount not to exceed ten thousand dollars (\$10,000) per violation.
- 20. As authorized by ORS 97.948(2)(g), the Director hereby ORDERS the assessment of CIVIL PENALTIES against Westrum in the total amount of seven thousand dollars (\$7,000), calculated as follows:
- A. A CIVIL PENALTY of five hundred dollars (\$500) per violation for the failure of Westrum to pay the 2014 annual certification renewal fees for each of the five Locations, in violation of ORS 97.933(1) and OAR 441-930-0270(1), for a total CIVIL PENALTY of two thousand five hundred dollars (\$2,500);
- В. A CIVIL PENALTY of five hundred dollars (\$500) per violation for the failure of Westrum to file 2013 annual reports for each of the five Locations, in violation of ORS 97.933(3)(a) and OAR 441-930-0250, for a total CIVIL PENALTY of two
