


Locating Education Courses:

You can find current Oregon registered courses at www.statebasedsystems.com

- Step 1. Jurisdiction: Choose Look Up
- Step 2. Search Type: Course or Provider
- Step 3. Course Group: Pharmaceutical Sales Representative
- Step 4. Agree to the NAIC Terms and Conditions and search

After you click “submit courses” a list of all available courses will be generated. To choose a course for credit click on the Course Name (Blue), from here you will contact the provider to sign up for the course.

Important Note: The Pre licensing courses are the options you will need to select for an initial application. Make sure you check the course #, education type, and group before signing up for a course. You will contact the course provider via their listed phone or email to sign up for a course.
