  - 90785: Interactive Complexity
  - Interactive complexity refers to specific communication factors that complicate the delivery of a psychiatric procedures.
  - This will be reported with other codes and won't stand on its own.
- Psychiatric diagnostic procedures
  - 90791: Psychiatric diagnostic evaluation
  - 90792: Psychiatric diagnostic evaluation with medical services
- Psychotherapy
  - 90832: Psychotherapy, 30 minutes with patient
  - 90833: Psychotherapy, 30 minutes with patient when performed with an E&M service
  - 90834: Psychotherapy, 45 minutes with patient

- 90836: Psychotherapy, 45 minutes with patient when performed with an E&M service
- 90837: Psychotherapy, 60 minutes with patient
- 90838: Psychotherapy, 60 minutes with patient when performed with an E&M service
- Psychotherapy for crisis
  - 90839: Psychotherapy for crisis; first 60 minutes
  - 90840: each additional 30 minutes
- Other psychotherapy
  - 90845: Psychoanalysis
  - 90846: Family psychotherapy (without the patient present), 50 minutes
  - 90847: Family psychotherapy (conjoint psychotherapy)/(with patient present) 50 minutes
  - 90849: Multiple-family group psychotherapy
  - 90853: Group psychotherapy (other than a multiple-family group)
- Health Behavior Assessment and Intervention
  - 96156: Health Behavior assessment/re-assessment
  - 96158: Health behavior ivntj indiv f2f 1<sup>st</sup> 30 min
  - 96159: Health behavior ivntj indiv f2f ea addl 15 min
  - 96164: Health behavior ivntj group f2f 1<sup>st</sup> 30 min

## Medical/surgical

- Office or other outpatient services
  - 99202: Office/outpatient new sf mdm 15-29 minutes
  - 99203: Office or other outpatient visit, new patient, typically 30 minutes
  - 99204: Office or other outpatient visit, new patient, typically 45 minutes
  - 99205: Office or other outpatient visit, new patient, typically 60 minutes
  - 99211: Office/outpatient est pt may not req phsy/qhp
  - 99212 Office/outpatient established sf mdm 10-19 minutes
  - 99213: Office/outpatient established low mdm 20-29 minutes
  - 99214: Office or other outpatient visit, established patient, typically 30-39 minutes
  - 99215: Office or other outpatient visit, established patients, typically 40-54 minutes
