### C. PROGRESS OF SECTION 1332 WAIVER - General

12. Provide an update on progress made in implementing and/or operating the approved 1332 waiver.

The Oregon Reinsurance Program's PPACA 1332 Waiver has been operating within the Standard Terms and Conditions (STD) of the 'Departments' with no current plans to make any changes to the STD at this time. Enrollment has been robust and current funding levels will support the OPR for the 2023 program year.

### **Enrollment report**

The 3rd quarter enrollment for Individual ACA compliant plans ending September 30, 2023 for both onand off-market totaled 160,596 members (on-exchange 126,844) (off-exchange 33,752). Enrollment numbers are approximately 1 percent lower than this time last year (167,270).

#### 2022 Healthcare Claims

The healthcare claims for the 2022 program year totaled \$398,222,862.28 for the six insurance carriers on the individual market. The program parameters for the 2022 program year are an attachment point of \$92,000 with a cap of \$1,000,000. The estimated coinsurance rate is 50 percent. Claims that reached the attachment point totaled 1,952 members far a total of \$207,526,761.19. The budget for the ORP was set at \$114,100,000. The health care claims for the 2022 program year have been processed and paid out to the six eligible health insurance carriers totaling \$103,763,380.80.

### **Public Forum**

Oregon held the PPACA 1332 Public Forum on July 21, 2023 virtually. The announcement was posted on the public e-mail address listserv and the ORP website on June 13, 2023. One member of the public observed the presentation.

#### Parameters for 2024

The Actuarial Firm NovaRest in collaboration with Division of Financial Regulation internal actuaries approved the parameters for the 2024 program year. The attachment points are \$95,000, cap of \$1 million and a proposed coinsurance rate of 50 percent.
