ITEM 14: AGREEMENT TO SUBMIT ENTERPRISE RISK REPORT UNDER ORS 732.523(2)(L)

Meiji Yasuda hereby agrees to submit an enterprise risk report under ORS 732.569 each year during which Meiji Yasuda controls Standard Insurance Company and StanCap Insurance Company, Inc. and acknowledges that Meiji Yasuda and all subsidiaries in its holding company system that are within Meiji Yasuda's control will provide, at the director's request, information the director needs to evaluate enterprise risk to the insurer.

ITEM 15: AGREEMENT TO PROVIDE INFORMATION REQUIRED BY FORM F

Meiji Yasuda hereby agrees to provide, to the best of its knowledge and belief, the information required by Form F within fifteen (15) days after the end of the month in which the acquisition of control occurs.
