In determining 14 the value of its assets, bonds held by the institution shall be valued in accordance with rules promulgated by the Director of the Department of Consumer and Business Services pursuant to ORS 183.310, 183.315, 183.330, 183.335 and 15 183.341 to 183.410. 16 (2) An Oregon stock bank fails to make good its reserve requirements under applicable law for a period of 30 days. 17 (3) The institution cannot meet its obligations or the demands upon it as they 18 become due." and 19 WHEREAS, after a thorough investigation of the affairs and condition of LibertyBank, headquartered in Eugene, Oregon, the Director is satisfied that the bank is insolvent within the meaning of ORS 711.405 and as such, the situation presents an immediate danger to the public 20 welfare justifying this action; 21 NOW, THEREFORE, BE IT RESOLVED AND DECLARED that pursuant to ORS 711.419, the Director does hereby take charge LibertyBank, headquartered in Eugene, Oregon, 22 and all of its properties and assets. 23 24 25 26
