**ENDOWMENT CARE FOR BURIAL VAULTS AND MARKERS  
PENAL BOND WITH SURETY**

(and if applicable) a corporation organized under the laws of the State of \_\_\_\_\_ and duly qualified and authorized to act as sole surety on bonds required by the State of Oregon, as surety, acknowledge our indebtedness to the State of Oregon in the sum of \$10,000, and obligate ourselves and our respective legal representatives and successors jointly and severally, to pay such sum, upon the following terms and conditions:

1. Principal proposes to enter into agreements to sell burial vaults or markers for installation in an endowment-care cemetery under the provisions of ORS 97.929(1)(c)(C)(i).
2. Pursuant to said law, principal must deposit, with the director of the Department of Consumer and Business Services, a bond in the amount of \$10,000 with a corporate surety.
3. The obligations of this bond are conditioned on the principal's full, faithful, and honest performance of the principal's obligations under the law and the agreement to sell burial vaults or markers for installation in an endowment-care cemetery where such burial vaults or markers are not in existence at the time of sale and are to be located in an endowment-care cemetery, and are further conditioned on the payment, by the principal, of any and all damages incurred by any purchaser or beneficiary as a consequence of the principal's failure to so perform.
4. If the principal and its agents and employees fully, faithfully, and honestly perform the principal's obligations under the law and the agreement to sell, this obligation shall be void. If the principal or its agents or employees violate the agreement to sell or commit acts that would otherwise violate the provisions of ORS 97.923 through 97.949 or ORS 692, and fail to pay all damages suffered by the purchasers or beneficiaries, then this obligation shall remain in full force and effect.
5. This bond may be terminated at the option of the surety upon providing the surety's provisions of 30 days' written notice to the director of the Department of Consumer and Business Services. Such termination shall apply to future liability only.

This bond is executed pursuant to ORS 97.929(1)(c)(C)(i) and is intended to comply with all the requirements of such statute.
