

Psychiatry (Page 647)

- Per the CPT coding book there may be instances where psychiatric services are reported using E&M codes.
 - E&M codes for consideration:
 - 99201 -99255
 - 99281-99285
 - 99304-99337
 - 99341-99350
- Interactive Complexity
 - 90785: Interactive Complexity
 - Interactive complexity refers to specific communication factors that complicate the delivery of a psychiatric procedure.
 - This will be reported with other codes and won't stand on its own.
- Psychiatric diagnostic procedures
 - 90791: Psychiatric diagnostic evaluation
 - 90792: Psychiatric diagnostic evaluation with medical services
- Psychotherapy
 - 90832: Psychotherapy, 30 minutes with patient
 - 90833: Psychotherapy, 30 minutes with patient when performed with an E&M service
 - 90834: Psychotherapy, 45 minutes with patient
 - 90836: Psychotherapy, 45 minutes with patient when performed with an E&M service
 - 90837: Psychotherapy, 60 minutes with patient
 - 90838: Psychotherapy, 60 minutes with patient when performed with an E&M service
- Psychotherapy for crisis
 - 90839: Psychotherapy for crisis; first 60 minutes
 - 90840: each additional 30 minutes
- Other psychotherapy
 - 90845: Psychoanalysis
 - 90846: Family psychotherapy (without the patient present), 50 minutes
 - 90847: Family psychotherapy (conjoint psychotherapy)/(with patient present) 50 minutes
 - 90849: Multiple-family group psychotherapy
 - 90853: Group psychotherapy (other than a multiple-family group)
- Other psychiatric services or procedures
 - 90863: Pharmacologic management, including prescription and review of medication, when performed with psychotherapy services
 - 90865: Narcosynthesis for psychiatric diagnostic and therapeutic purposes
 - 90867: Therapeutic repetitive transcranial magnetic stimulation (TMS) treatment; initial; including cortical mapping, motor threshold determination, delivery and management
 - 90868: Subsequent delivery and management, per session (see 90867)
 - 90869: Subsequent motor threshold re-determination with delivery management
 - 90870: Electroconvulsive therapy (includes necessary monitoring)

- 90875: Individual psychophysiological therapy incorporating biofeedback training by any modality, with psychotherapy; 30 minutes
 - 90876: 45 minutes
- 90880: Hypnotherapy
- 90882: Environmental intervention for medical management purposes on a psychiatric patient's behalf with agencies, employers, or institutions
- 90885: Psychiatric evaluation of hospital records, other psychiatric reports, psychometric and/or projective tests, and other accumulated data for medical diagnostic purposes
- 90887: Interpretation or explanation of results of psychiatric, other medical examinations and procedures, or other accumulated data to family or other responsible persons, or advising them how to assist the patient
- 90889: Preparation of a report of patient's psychiatric status, history, treatment, or program (other than for legal or consultative purposes) for other individuals, agencies, or insurance carriers
- 90899: Unlisted psychiatric service or procedure

General medical/surgical codes for comparative consideration (Page 11)

- Office or other outpatient services
 - 99203: Office or other outpatient visit, new patient, typically 30 minutes
 - 99204: Office or other outpatient visit, new patient, typically 45 minutes
 - 99205: Office or other outpatient visit, new patient, typically 60 minutes
 - 99214: Office or other outpatient visit, established patient, typically 25 minutes
 - 99215: Office or other outpatient visit, established patients, typically 40 minutes
